

Where to File



Family members* and law enforcement officers can file a [petition](#) to obtain an FRO with the Circuit Court in which the person about whom you are worried resides. If a loved one is experiencing an emotional crisis or is demonstrating signs of being dangerous such as suicidal thoughts, aggression, public threats of violence, or is exhibiting other dangerous behaviors, you can consider contacting your local sheriff or police department, to inform them of a dangerous situation.

**Includes spouse, parent, grandparent, child, or step-child of the respondent, or a person who shares a common dwelling with the respondent. See relationship code on FRO [petition](#) form for all eligible relationship statuses.*
